New Virginia Laws Effective July 1

Motor Fuel Taxes Increasing

As we have previously reported, in 2020 the General Assembly passed legislation that ties' motor fuel tax rates to the increase in the Consumer Price Index. This year that change meatax on gasoline and diesel will increase 1.3 cents per gallon for all product dispensed after 1 July 1. The DMV tables detailing these changes may be found below:

Increased Fines, Education Mandates and Possible License Suspensions for Underage Tobacco/Vape Products

New legislation increases penalties for sales of tobacco and vape products to underage per included in the law is language requiring mandatory education on these topics for both store employees. We have been trying without success to determine the format of these educatio mandates, but have been rebuffed by the Department of Behavioral Health, and concerned new mandates may well be released after the effective date without the benefit of public inp by subject matter experts. We will continue to work to develop the information necessary to membership and will be supplying this information when made available by the state.

Distributor/Dealer Market Survey

Also taking effect Monday is legislation regarding distributor/dealer relationships. After cons and deliberation during the process, the following becomes law Monday:

Be it enacted by the General Assembly of Virginia:

1. That the Code of Virginia is amended by adding a section numbered 59.1-21.11:2 as folk

§ 59.1-21.11:2. Required provisions pertaining to agreements between jobber/distributors a

A. A term of an initial agreement between a jobber/distributor and a dealer relating to specific premises shall not be less than one year, and the term of all subsequent agreements betwee jobber/distributor and the dealer relating to the same marketing premises shall not be for less years. The rental provisions in any such agreement or franchise shall be based on comment reasonable standards at a fair market value of the leased marketing premises. If a dealer between the agreement offered do not meet a fair market value, such dealer may hire, at his independent third-party appraisal company from a list of appraisal companies provided by the jobber/distributor to provide a market valuation study. Such study shall (i) be for information only, (ii) not require either party to disclose confidential business information, and (iii) not bit party.

B. The provisions of this section shall be limited to Planning District 8 and shall apply to initiagreements and renewals of franchise agreements entered into after July 1, 2024.

It is important to note that the bill only applies to locations in Virginia's planning district 8: Dt Loudoun, Prince William, Manassas, Manassas Park, Fairfax, Fairfax County, Fall Church, Leesburg, Vienna, Arlington and Alexandria, and the market survey provision is only applica contracts entered into after July 1, so our expectation is that the impacts will be minimal, at short term. As we have announced, our leadoff speaker at the Annual Meeting at the Greet State Senator Jeremy McPike who has been the chief proponent of regulation of distributor, relationships.
