

## Annual Meeting Registration Opens Today Join us September 27-29, at The Greenbrier

At the 72nd annual meeting at the Greenbrier we will be honoring many of the association's long-standing traditions while making some new ones in the COVID-19 era. We have an outstanding room rate this year (which they will honor the 26th-Oct 1 for anyone who wishes to stay longer.) Our room rate this year is \$219 single or double which contrasts with our 2018 rate of \$319/\$455 which also included breakfast and dinner. Our registration fee has remained the same for five years and includes your spouse at no additional charge (except Monday afternoon activities which have an additional registration fee.) One noticeable change is that we have removed ties from the recommended attire for Sunday evening and will go

with resort casual with a jacket suggested for gentlemen for Sunday's reception, dinner and awards. Remember, a jacket is required to enter the casino. All of our sessions, receptions and Sunday dinner will be held practicing social distancing and masks will be available.

## Virginia DEQ Guidance Documents on UST

The Virginia Department of Environmental Quality has developed a guidance document for internal and stakeholder use outlining requirements for its new underground storage tank regulations. This guidance discusses the new regulatory requirements contained in 9VAC25-580 et seq.that tank owners/operators must comply with as of January 1, 2021. Among the topics covered are release detection, equipment testing, overfill protection, sump testing and inspection requirements. The full document is available <a href="here">here</a>. ## PMAA Regulatory Alert: PHMSA Extends Enforcement Discretion Policy for CDL Driver HAZMAT Training

The Pipeline and Hazardous Material Safety Administration (PHMSA) announced an extension of the agency's March 24, 2020 enforcement discretion policy (waiver) regarding reoccurring hazardous material training and testing requirements for CDL drivers. While the waiver is in effect, PHMSA will take no enforcement action against any motor carrier or offeror who is unable to provide reoccurring hazardous material training and testing that all CDL HAZMAT drivers (and all HAZMAT employees) must undergo every three years. The original enforcement waiver expired on June 24, 2020. <a href="PHMSA's announcement">PHMSA's announcement</a> this week extends the waiver through October 31, 2020.

## PMAA Regulatory Report: FMCSA Extends Waiver for Expiring CDL Licenses, Learner's Permits and Driver Medical Certificates

The Federal Motor Carrier Safety Administration (FMCSA) has issued a three-month extension of the emergency waiver validating expiring commercial driver licenses (CDL), commercial learner's permits (CLP), and driver medical qualification certificates that expires

on June 30th. The new emergency waiver takes effect July 1 and ends on September 30, 2020. The waiver applies to both intrastate and interstate drivers. The FMCSA said the waiver extension is necessary due to the ongoing closures of state licensing agencies and certified medical examiners that prevent drivers from renewing their CDL, CLP and medical certificates.
