Important Survey on CDL Waiver Extensions for FMCSA and TSA From PMAA

PMAA Regulatory Counsel Mark Morgan needs your help to relay some information to the Transportation Security Administration (TSA) and the Federal Motor Carrier Safety Administration (FMCSA) regarding possible extension of waivers for renewal of expired or expiring commercial driver licenses (CDL) and hazardous material endorsements (HME) currently in effect nationwide. The CDL waiver ends September 30, 2020 while the HME waiver ends on October 29, 2020.

PMAA has heard from drivers in many states where they are required to schedule appointments to renew expired or expiring CDLs and HMEs at their local Department of Motor Vehicles that have received dates long after the current waivers expire. TSA and FMCSA asked PMAA to collect information on where the delays are happening. This survey link below is designed to provide the required information the TSA and FMCSA is necessary if the CDL and HME waivers are to be extended.
